RE: Canada Post Strike, Interruption of Postal Service

The Canadian Union of Postal Workers commenced strike action on November 15, 2024. As you have chosen to receive royalty and/or lease rental payments by physical cheque, delivery of these payments are potentially at risk due to this postal strike.

Tundra Oil & Gas Limited (“Tundra”) will continue efforts to make royalty and rental payments as follows:

- 1) Payments currently made by Electronic Funds Transfer (EFT) are unaffected.
- 2) Where Tundra has a civic addresses (street address) on file, payment will be couriered to that address – no signature will be required for delivery, as would be the case for mail delivery.
- 3) Courier services do not deliver to P.O. Box or Rural Route addresses. If your address with Tundra is a P.O. Box or Rural Route, cheques will be held for pick-up at your choice of Tundra office.

Please reply to royaltypayments@tundraoilandgas.com **before the end of day December 9th**, indicating your Business Associate (BA) number in the subject line (found above your name on top left corner of your royalty / rental statement) and the Tundra office where you wish to pick up the cheque that you would have normally received by mail in December. Cheques are anticipated to be available for pick up on or after **December 12th** (8am – 4pm local time).

- 4) Payments to addresses in the United States will be processed through the United States Postal Service and should not be impacted.
